Brief description of works undertaken:

Project 1.

Following a substantial water leak from pipework in the pavilion roof resulting in damage to the interior during the winter of 2022/23, upgrading of all pipework from copper to plastic has been undertaken plus improved roof insulation.

The damage caused was disruptive to clubs and a risk for ongoing use by the community for events such as the village fete. The work has been successful and is a significant improvement for the pipework and insulation to prevent heat loss. The upgrade will ensure that this asset will be fit for community use for many years to come. Additional funds of £240 were allocated from the Precept.

As a tribute to Queen Elizabeth II a new open space area has been created with bench seating and garden comprising two Cherry trees, flower borders and rear sleeper wall at the footpath entrance to Otterbourne Primary School off Cranbourne Drive.

The new area has provided a lovely entrance to the school and a new meeting place for parents and carers who drop off/collect schoolchildren.
